

What is a lighthouse initiative?

Initiative in development to develop visionary, large-scale offshore wind energy research projects that will address grand scientific and technical challenges that are crucial for the further advancement of offshore wind energy, providing new knowledge and basis for innovation.

They will have substantial budgets (tens of million EUR) and duration (5 years or more) and bring together excellent research teams across relevant disciplines, sharing a joint goal to advance offshore wind energy and an ambitious research roadmap on how to achieve it.




