### The ETIPWind report: why?



**EU funding is not optimal, we need to change the mindset.** European policymakers take to heart the recommendations from the Draghi and Heitor reports. We need to show how these can be applied to the wind sector to optimise wind energy funding in the next EU budget. The European wind sector agrees on a common R&I agenda by 2050. We need to provide clarity on this common R&I programme so we can align funding with EU Member States and the European Commission.










